Thank you for your inquiry regarding the unique educational opportunity available at Foothills Christian High School. FCHS offers an exceptional blend of Christian classroom instruction coupled with independent study. Students attend classes in a normal class-to-class format three days per week (Tuesday through Thursday) to receive classroom interaction, instruction and assignments for the entire week. On Mondays and Fridays students are engaged in independent study involving an online learning program. Families can also utilize the tutorial option available for Monday and Friday to receive additional help.

FCHS is an accredited educational institution (WASC) registered with the State of California. Our students enjoy the benefits of committed Christian teachers working in small classroom settings averaging less than 20 students per teacher. This atmosphere allows the fullness of a Biblically-integrated curriculum and the development of crucial critical thinking skills. As a school of about 240 students, we provide a wealth of academic opportunities including honors English, Math, Science, History, and some AP courses. There are also a variety of electives available. We offer a diverse athletic program with 12 varsity sports and participation in the Southern Conference of the CIF.

Most importantly, we offer our commitment to Christ and an opportunity for our student body to grow in their knowledge of God. Our Bible program includes weekly chapel services with a student-led worship band. Faculty and guest speakers bring a wealth of experience, challenging students to exercise and increase their faith. Every year students are required to take a Bible course that will facilitate their personal development and experience of the Lord Jesus.

Enrollment at Foothills Christian High School is limited to those who pass the screening process. Students must respond to a series of questions with a short essay. Evaluation forms must also be submitted by their pastor or church leader as well as one from a current school teacher or administrator with knowledge of their academic experience. A personal interview is required which involves the student, a parent and an FCHS administrator. A non-refundable application fee of \$75 must accompany the application. ## STATEMENT OF FAITH

## **ADMISSIONS POLICY**

Foothills Christian High School does not discriminate on the basis of race, color, national or ethnic origin. Matriculation at Foothills Christian High School is a privilege - not a right; therefore, each applicant is carefully evaluated prior to acceptance. At a minimum, each student should exhibit a sincere desire to follow Jesus Christ and glorify Him in everything they do.

In some cases, it may be in the best interest of the student or the school to refuse the enrollment or re-enrollment request of a student. Foothills Christian High School's ability to meet the needs of each student and the school's stated purpose is critical to the admissions process. Therefore, careful consideration of the student's needs and the school's policies should be exercised prior to the submittal of an application.

### **Admission will be determined by the following criteria:**

- The student's desire to mature in a personal relationship with Jesus Christ as evidenced by their statement of faith and their pastors' evaluation.
- The student's attendance and participation in church and youth group activities.
- The student's willingness to attend Foothills Christian High School and submit to the Rules of Conduct and Dress Code of the school.
- The student's academic and social record to date.
- The student's academic, special, and financial needs.
- The student's and parents' commitment towards the student's education.

## FINANCIAL POLICY and FEE SCHEDULE - effective for the 2011/12 school year

AN APPLICATION FEE of \$75.00\* is due with application.

**REGISTRATION FEES:** (If application is received on or before June 3<sup>rd</sup> there will be a \$75 reduction from registration fees.)

**NEW ENROLLMENTS** are \$300.00\*, due by July 1 or **at the time of acceptance.**

**RETURNING** FCHS or FCS students are \$250.00\* due by July 1.

**\*ALL FEES ARE NON-REFUNDABLE.**

**TUITION** is charged annually and may be divided into monthly payments. Payments are divided over eleven (11) months, beginning August 1<sup>st</sup> and ending June 1<sup>st</sup>.

**FOOTHILLS CHRISTIAN CHURCH MEMBERS AND VOCATIONAL MINISTRY DISCOUNT:** may apply for a \$40 discount. The form is available in the school office.

**FINANCIAL AID:** upon acceptance of the student, if financial aid is needed, forms are available in the Administration office. No other discounts may apply if approved for financial aid.

**SIBLING DISCOUNT:** if you have two or more children enrolled at FCHS you may be granted a 10% discount per sibling.

Discounts cannot be used in tandem.

**WITHDRAWAL** Tuition payments are non-refundable. In the event that a student is withdrawn from FCHS, there will be a withdrawal fee of \$75 which covers all the administrative tasks required to process a student.

**RETURNED CHECKS** are charged a \$25.00 fee and require replacement in the form of a money order or cash. A second returned check requires future payments be made in cash or with a money order.

**FINANCIAL CONTRACT** will be sent with your student's acceptance letter or given at the time of interview. If you are applying for Financial Aid and it is granted you will need to fill out a Financial Aid Contract.

1. The tuition payment is due on the first of each of month.
2. Payment is late if not received **by the 15<sup>th</sup> of the month.** If the 15<sup>th</sup> falls on a holiday or weekend, payment is due the following business day.
3. Payments received after the 15<sup>th</sup> of the month, will be assessed a 10% late fee against the monthly tuition.
4. Upon written request, FCHS School Board Finance Committee may grant payment extensions. The written request must be received in the Administration Office by the 15<sup>th</sup> of the month.
5. Accounts in arrears, without prior approval, FCHS have the discretion to remove the student from attending school the following month.
6. Each semester FCHS reviews delinquent accounts over 60 days or has defaulted on a payment extension, at which time, FCHS has the discretion to remove the student from attending school until all tuition and fees are paid in full for the semester with cash or money order.
7. No transcript will be given out to students with delinquent accounts.
