__ If more than one check is returned unpaid by the bank, future bills must be paid with a cashier's check or money order.

__ If tuition falls behind 30 days, you may be asked to keep your student(s) at home until the account is brought current.

__ If you anticipate any financial difficulties that would keep you from making your payment on time, contact the office **BEFORE** the due date, to make "temporary" arrangements.
